	Introduction to the Problem-Solving Model and Learning Resources	Students reflect on learning a new skill and the variety of ways they learn. The problem-solving model, TEKS mathematical process standards, and the Academic Glossary help students complete a problem-solving activity. Students reflect on and summarize the problem-solving model. Since the intent of this lesson is to introduce the problem-solving model and review the TEKS mathematical process standards, the focus is on process not content. Students will need access to the Academic Glossary, Problem-Solving Model Graphic Organizer, Problem-Solving Questions to Ask, and TEKS mathematical process standards, which are located in the Course Guide. These materials should always be available to students throughout the course.	<ul style="list-style-type: none"> <li>Create a classroom of collaboration and establish the learning process as a partnership between you and your students.</li> <li>Communicate continuously with students about the objectives of the lesson to encourage self-monitoring of their learning.</li> <li>The problem-solving model involves noticing patterns and formulating questions, organizing information and representing this information using appropriate mathematical notation, analyzing mathematical representations and using them to make predictions, and then testing predictions, predicting, and sharing the results.</li> <li>The TEKS mathematical process standards describe the ways in which students are expected to engage in content.</li> <li>The Academic Glossary is a resource that helps students think, reason, and communicate their ideas.</li> </ul>	8.10C	0
1	Introduction to Congruent Figures	Students use patty paper to indirectly measure segments and angles and use folds to make observations about a figure. They determine whether figures are the same size and shape. The term <i>congruent figures</i> is defined. Students use patty paper to determine whether figures are congruent. They then make conjectures about congruence, investigate their conjectures, and justify their conjectures using informal transformation language.	<ul style="list-style-type: none"> <li>Patty paper is a hands-on tool for investigating geometric ideas.</li> <li>If two figures are <i>congruent figures</i>, all corresponding sides and all corresponding angles have the same measure.</li> <li><i>Corresponding sides</i> are sides that have the same relative position in geometric figures.</li> <li><i>Corresponding angles</i> are angles that have the same relative position in geometric figures.</li> <li>A rigorous study of geometry requires making conjectures, investigating conjectures, and justifying true results.</li> </ul>	8.10A	2
2	Introduction to Rigid Motions	Students develop a formal understanding of translations, rotations, and reflections in the plane. The terminology of transformations is introduced, including <i>pre-image</i> , <i>image</i> , <i>translation</i> , <i>reflection</i> , <i>line of reflection</i> , <i>rotation</i> , <i>center of rotation</i> , and <i>angle of rotation</i> . Students use patty paper to investigate each transformation, create images from pre-images, and determine the properties of each transformation. They learn that each rigid motion transformation preserves the size and shape of the original figure, and that translations and rotations also preserve the orientation of the figure. At the end of the lesson, students state the formal name for transformations that carry figures onto congruent figures and reason that an image of a pre-image is congruent to the pre-image.	<ul style="list-style-type: none"> <li><i>Transformations</i> are mappings of a plane and all the points of a figure in a plane according to a common action or operation.</li> <li><i>Rigid motions</i> are transformations that preserve segment length, angle measure, and parallelism of segments.</li> <li>Translations, rotations, and reflections are rigid motions.</li> <li>The <i>pre-image</i> of a figure is the original figure. The <i>image</i> is the result of a transformation.</li> <li><i>Translations</i> “slide” a figure in a given direction by a specific distance.</li> <li><i>Reflections</i> “flip” a figure across a line of reflection.</li> <li><i>Rotations</i> “spin” a figure given a center of rotation, by an angle of rotation, in a given direction.</li> </ul>	8.10A 8.10B	3

3	Translations of Figures on the Coordinate Plane	Students use patty paper to explore translations of various figures on a coordinate plane. They then generalize about the effects of translating a figure on its coordinates. Students verify that two figures are congruent by describing translations that map one figure onto another.	<ul style="list-style-type: none"> <li>A translation is a transformation that moves each point of a figure the same distance and direction.</li> <li>A point with the coordinates <math>(x, y)</math>, when translated horizontally by <math>c</math> units, has new coordinates <math>(x + c, y)</math>. A point with the coordinates <math>(x, y)</math>, when translated vertically by <math>c</math> units, has new coordinates <math>(x, y + c)</math>.</li> </ul>	8.10A <b>8.10C</b>	2
4	Reflections of Figures on the Coordinate Plane	Students use patty paper to explore reflections of various figures on a coordinate plane. They then generalize about the effects reflecting a figure has on its coordinates. Students verify that two figures are congruent by describing reflections that map one figure onto another.	<ul style="list-style-type: none"> <li>A reflection is a transformation that flips a figure across a reflection line.</li> <li>A reflection line is a line that acts as a mirror, or perpendicular bisector, so that corresponding points are the same distance from the mirror.</li> <li>When a geometric figure is reflected across the <math>y</math>-axis to form its image, the <math>x</math>-values of the ordered pairs of the vertices of the pre-image become opposites, and the <math>y</math>-values of the ordered pairs of the pre-image remain the same.</li> <li>When a geometric figure is reflected across the <math>x</math>-axis to form its image, the <math>y</math>-values of the ordered pairs of the vertices of the pre-image become opposites, and the <math>x</math>-values of the ordered pairs of the pre-image remain the same.</li> <li>A point with the coordinates <math>(x, y)</math>, when reflected across the <math>x</math>-axis, has new coordinates <math>(x, -y)</math>. A point with the coordinates <math>(x, y)</math>, when reflected across the <math>y</math>-axis, has new coordinates <math>(-x, y)</math>.</li> </ul>	8.10A <b>8.10C</b>	2
5	Rotations of Figures on the Coordinate Plane	Students use patty paper to explore rotations of various figures on a coordinate plane. They then generalize about the effects of rotating a figure on its coordinates. Students verify that two figures are congruent by describing a rigid motion that maps one figure onto another.	<ul style="list-style-type: none"> <li>A rotation is a transformation that turns a figure clockwise or counterclockwise about a fixed point for a given angle and a given direction.</li> <li>An angle of rotation is the amount of clockwise or counterclockwise rotation about a fixed point.</li> <li>The point of rotation can be a point on the figure, in the figure, or outside the figure.</li> </ul>	8.10A <b>8.10C</b>	2
6	Congruence and Rigid Motions	Students use coordinates to determine the rigid motion used to map one congruent figure onto another. They learn about and write congruence statements for congruent triangles. Using a coordinate plane, students determine whether two figures are congruent. They then generalize the effects of rigid motions on the angle measures, side lengths, area, and perimeter of the figures.	<ul style="list-style-type: none"> <li>Rigid motions produce congruent figures.</li> <li><i>Congruent line segments</i> are line segments that have the same length.</li> <li><i>Congruent angles</i> are angles that have equal measures.</li> <li>Congruent figures can be mapped from one to another using translations, reflections, and rotations.</li> <li>There is often more than one sequence of transformations that can be used to map from one congruent figure onto another one.</li> <li>The effects of rigid motion transformations on the coordinates of figures can be generalized.</li> </ul>	8.10A <b>8.10C</b>	2

1	Dilations of Figures	Students explore dilations on the plane. The terms <i>dilation</i> , <i>center of dilation</i> , <i>scale factor</i> or <i>dilation factor</i> , <i>enlargement</i> , and <i>reduction</i> are defined. Students dilate a variety of objects and figures using scale factors greater than 1 and between 0 and 1. They use a model to determine side lengths and angle measures after enlargements and reductions in order to verify similarity. Students connect dilations to changing image sizes in word processing and graphics software.	<ul style="list-style-type: none"> <li>Dilation is a transformation that produces images that are the same shape as the pre-image, but not the same size.</li> <li>When a figure is dilated with a <i>scale factor</i> greater than 1, the resulting figure is a similar figure that is an <i>enlargement</i> because each side length is multiplied by a scale factor that is larger than the identity factor of 1.</li> <li>When a figure is dilated with a scale factor between 0 and 1 the resulting figure is a similar figure that is a <i>reduction</i> because each side length is multiplied by a scale factor that is smaller than the identity factor of 1.</li> </ul>	8.3A 8.10A	2
2	Dilating Figures on the Coordinate Plane	Students build dilations on the coordinate plane as repeated geometric translations using the origin as the center of dilation. Throughout this lesson, students create and adjust conjectures about the effect of dilations with the origin as the center on the coordinates, perimeter, and area of a figure. They use dilations and transformations they learned previously to verify that two figures are similar.	<ul style="list-style-type: none"> <li>Dilation is a transformation that produces images that are the same shape as the pre-image, but not the same size.</li> <li>When a figure is dilated on the coordinate plane, the resulting figure is similar to the original figure.</li> <li>Each coordinate <math>(x, y)</math> point on a figure is multiplied by the scale factor when the figure is dilated using the origin as the center of dilation.</li> <li>When a figure is dilated using the origin as the center of dilation, the perimeter of the new figure is the scale factor multiplied by the perimeter of the original figure. The area of the new figure is the square of the scale factor multiplied by the area of the original figure.</li> </ul>	8.3B 8.3C 8.10B 8.10D	2
3	Mapping Similar Figures Using Dilations	Students determine whether figures are similar through dilations. They explore what is meant by "same shape" when referring to similar figures. Students determine similarity using a single dilation and write the ratio of corresponding sides of similar shapes. Finally, students summarize the relationships between transformations and congruent and similar figures.	<ul style="list-style-type: none"> <li>The corresponding sides of similar shapes are proportional.</li> <li>Dilations create similar figures.</li> </ul>	8.3A 8.3C 8.10A 8.10B	2

Lesson	Lesson Title	Lesson Summary	Essential Ideas	TEKS*	Pacing*
1	Exploring Angle Theorems	Students explore and justify the relationships between angles and sides in a triangle. They establish the Triangle Sum theorem and use the theorem as they explore the relationship between interior angle measures and the side lengths of triangles. Students identify exterior angles and remote interior angles of triangles and explore the relationship between these angles to establish the Exterior Angle theorem. They then practice applying both theorems to demonstrate their knowledge of triangle relationships.	<ul style="list-style-type: none"> <li>The <i>Triangle Sum theorem</i> states that the sum of the measures of the interior angles of a triangle is <math>180^\circ</math>.</li> <li>The longest side of a triangle lies opposite the largest interior angle.</li> <li>The shortest side of a triangle lies opposite the smallest interior angle.</li> <li>The <i>remote interior angles of a triangle</i> are the two angles non-adjacent to the exterior angle.</li> <li>The <i>Exterior Angle theorem</i> states that the measure of the exterior angle of a triangle is equal to the sum of the measures of the two remote interior angles of the triangle.</li> </ul>	8.8D	2
2	Exploring the Angles Formed by Lines Intersected by a Transversal	Students explore the angles formed when two lines are intersected by a transversal. They use the Parallel postulate and transformations to begin exploring and identifying the angles. The terms <i>transversal</i> , <i>alternate interior angles</i> , <i>alternate exterior angles</i> , <i>same-side interior angles</i> , and <i>same-side exterior angles</i> are introduced. Students are given a street map and asked to identify transversals and special pairs of angles. After measuring several angles, they conclude that when two parallel lines are intersected by a transversal, the alternate interior, alternate exterior, and corresponding angles are congruent. Students also conclude that same-side interior and same-side exterior angles are supplementary. When the lines are not parallel, these relationships do not hold true. Finally, students solve problems using the parallel line and angle relationships.	<ul style="list-style-type: none"> <li>A <i>transversal</i> is a line that intersects two or more lines.</li> <li>When two parallel lines are intersected by a transversal, corresponding angles are congruent.</li> <li>When two parallel lines are intersected by a transversal, <i>alternate interior angles</i> are congruent.</li> <li>When two parallel lines are intersected by a transversal, <i>alternate exterior angles</i> are congruent.</li> <li>When two parallel lines are intersected by a transversal, <i>same-side interior angles</i> are supplementary.</li> <li>When two parallel lines are intersected by a transversal, <i>same-side exterior angles</i> are supplementary.</li> <li>Parallel line and angle relationships can be proven using transformations.</li> </ul>	8.8D	2
3	Exploring the Angle-Angle Similarity Theorem	The Angle-Angle Similarity theorem can be used to show that two triangles are similar. From previous lessons, students should already recognize that two similar triangles have congruent corresponding angles and proportional corresponding sides. The Angle-Angle Similarity theorem allows students to show that two triangles are similar without comparing the measures of the six parts of each triangle.	<ul style="list-style-type: none"> <li>The Angle-Angle Similarity theorem (AA) states that if two angles of one triangle are congruent to the corresponding angles of another triangle, then the triangles are similar.</li> <li>The Angle-Angle Similarity theorem can be applied to identify similar triangles in problem situations.</li> </ul>	8.8D	2

## TOPIC 1: From Proportions to Linear Relationships

Lesson	Lesson Title	Lesson Summary	Essential Ideas	TEKS*	Pacing*
1	Representations of Proportional Relationships	Students examine a context which presents a proportional relationship with a ratio and use this ratio to write equivalent ratios. They further analyze this context by creating a table of values and matching equations to situations. Students then generalize this representation to an equation in the form $y = kx$ , identifying $k$ as the constant of proportionality. Next, students analyze scenarios involving proportional relationships, also known as direct variation, represented in different forms. They end the lesson by analyzing and describing the general characteristics of proportional relationships as represented in graphs, tables, and equations. Later in the topic, students will use these general characteristics to contrast proportional linear relationships with non-proportional linear relationships.	<ul style="list-style-type: none"> <li>A proportional relationship is one in which the ratio of two quantities is constant.</li> <li>A proportional relationship is represented as a linear graph passing through the origin.</li> <li>A proportional relationship is represented as a table with the values that increase or decrease at a constant rate, beginning or ending with (0, 0).</li> <li>The equation for a proportional relationship is written in the form <math>y = kx</math>, where <math>k</math> is the constant of proportionality.</li> <li>A proportional relationship can also be referred to as a direct variation. The <math>y</math>-value varies directly with the <math>x</math>-value, therefore the ratio of <math>y</math> to <math>x</math> is constant for every point. When two quantities vary directly, the points on a graph form a straight line, and the line passes through the origin.</li> </ul>	8.4B 8.4C 8.5A 8.5E 8.5H	3
2	Using Similar Triangles to Describe the Steepness of a Line	Students connect the previously learned concepts of unit rate, constant of proportionality, and scale factor with the concept of slope, which is introduced here as the rate of change of the dependent quantity compared to the independent quantity. In this lesson, slope is defined as the steepness and direction of a line. The formula to calculate slope is introduced in the next topic. Students derive the equation for a proportional relationship, $y = mx$ . By translating the line $b$ units, they derive the equation for a non-proportional linear relationship, $y = mx + b$ . They practice writing equations from graphs. Students begin with incomplete tables and graphs to create their own proportional and non-proportional linear relationships. They also investigate the slope of a horizontal line.	<ul style="list-style-type: none"> <li>A rate of change is used to describe the rate of increase or decrease of one quantity relative to another quantity.</li> <li>A unit rate is a comparison of two measurements in which the denominator has a value of one unit.</li> <li>The rate of change is the same for any two points on a line.</li> <li>The slope of a line describes its steepness and direction.</li> <li>An increasing line has a positive slope; a decreasing line has a negative slope.</li> </ul>	8.4A 8.4B 8.4C 8.5F 8.5H	3
3	Exploring Slopes Using Similar Triangles	Students use similar triangles to explain why the slope is the same between any two distinct points on a non-vertical line. They develop this understanding by taking two points on a line and drawing a segment horizontally from one point and a segment vertically from the other point until the two segments intersect to form a right triangle. The right triangles formed are verified to be similar using transformations, patty paper, and properties of angles formed by parallel lines. Using the relationship between the ratios associated with the corresponding sides of similar triangles, students demonstrate that the slope of any two points on the non-vertical line is the same. They explore this concept first using a line in the form $y = mx$ and then with lines in the form $y = mx + b$ with positive and negative slopes.	<ul style="list-style-type: none"> <li>The properties of similar triangles constructed on a line can explain why the slope is the same for any two points on a line.</li> <li>All right triangles formed on a given line are similar.</li> <li>The horizontal and vertical side lengths of right triangles formed on a given line can be substituted in the ratio <math>\frac{\text{change in vertical distance}}{\text{change in horizontal distance}}</math> to calculate the slope of the line.</li> </ul>	8.4A	2

4	Transformations of Lines	Students apply geometric transformations to the basic function, $y = x$ , first reviewing the effects of transformations on geometric figures in the coordinate plane. They use patty paper to investigate the relationship between translations of $y = x$ , noting that the images have the same slope as the pre-image and different y-intercepts. Students then investigate graphs with the same y-intercept but different slopes and recognize $y = mx$ as a dilation of $y = x$ by a factor of $m$ . Students graph several equations with the same slope and conclude that the lines have a parallel relationship.	<ul style="list-style-type: none"> <li>When a line is dilated by a non-zero factor other than 1, the slope of the line changes by the factor.</li> <li>When a line is translated horizontally or vertically, the slope remains the same but the intercepts change.</li> <li>Linear relationships can be graphed using transformations.</li> <li>When lines are parallel to each other, the slope values in their equations are equal.</li> <li>Translating a line results in a line parallel to the original line.</li> <li>Rotating parallel lines results in parallel lines.</li> <li>Reflecting parallel lines results in parallel lines.</li> </ul>	8.3C 8.4B 8.4C 8.5B 8.5F 8.10C	3

1	Using Tables, Graphs, and Equations	Tables, graphs, and equations can provide different representations of the same problem situation. Students create equations, tables, and graphs to analyze linear relationships. Students compare and analyze the local shop and online store problem situations algebraically and graphically. They then write a response that compares the pricing plans for the two companies and predict how the pricing by the online store will affect the business of the local shop.	<ul style="list-style-type: none"> <li>Two linear relationships can be compared algebraically.</li> <li>Two linear relationships can be compared graphically.</li> </ul>	8.5B 8.5I	2
2	Linear Relationships in Tables	Students analyze a table of values within a context and determine the rate of change by using its formal definition. Students use the formula $m = \frac{y_2 - y_1}{x_2 - x_1}$ to determine the rate of change for a table of values (or two points). Students combine their knowledge of linear relationships and their skill of determining rate of change from a table of values in order to determine whether a given table of values represents a linear relationship. This process includes the special case of examining first differences.	<ul style="list-style-type: none"> <li>The formula <math>m = \frac{y_2 - y_1}{x_2 - x_1}</math>, where the first point is <math>(x_1, y_1)</math> and the second point is <math>(x_2, y_2)</math>, can be used to calculate the rate of change of a linear relationship from a table of values or two coordinate pairs.</li> <li>When the rate of change between consecutive ordered pairs in a table is the same value every time, the table of values represents a linear relation.</li> <li>First differences are the values determined by subtracting consecutive y-values in a table when the x-values are consecutive integers. When the first differences are the same every time, the table of values represents a linear relationship.</li> </ul>	8.4A 8.4C 8.5F	2
3	Linear Relationships in Context	Students analyze a context that represents linear relationships among distance, cost, and gallons of gas. They represent the same context using different independent and dependent quantities, each time calculating the rate in order to connect processes and representations. Students then determine the unit rate from a variety of contexts. Some contexts provide rates that must be interpreted and restated using the given units and labels, while others provide two data points, giving students the opportunity to use the formula $m = \frac{y_2 - y_1}{x_2 - x_1}$ .	<ul style="list-style-type: none"> <li>A context representing a linear function often provides enough information to determine the rate of change of the function.</li> <li>There are similarities in the processes of determining the rate of change from a context, graph, and table.</li> <li>In order to calculate a unit rate from a context representing a linear function, a rate, or two data points, must be provided.</li> </ul>	8.4C	1

4	Slope-Intercept Form of a Line	Students formalize the initial value of a linear relationship, or the point where the line crosses the $y$ -axis, as the $y$ -intercept of the graph. They learn the notation for $y$ -intercept and determine $y$ -intercept informally from graphs. Students then use the slope formula to determine the value of the $y$ -intercept and to derive the slope-intercept form of a linear equation. 1	Simple and Compound Interest	This lesson begins with developing a conceptual understanding of growth functions. Students informally compare linear and exponential growth through a pay scenario, and they then compare simple interest and compound interest for a specific investment through a given table of values. Next, students extend their understanding to other representations and develop the mathematical skills involved in calculating simple and compound interest. They deal with two other representations—graphs and equations—for both types of interest. They are given different representations of interest problems, and they determine whether each problem refers to simple or compound interest. Students calculate simple interest using a formula and compound interest using both a table and a formula.	<ul style="list-style-type: none"> <li>When comparing the behavior of growth functions, the <math>y</math>-values of a linear function with a high constant rate will eventually be surpassed by the <math>y</math>-values of an exponential function with a much lower, but increasing, rate as the value of <math>x</math> increases.</li> <li>An investment/loan with compound interest increases much more quickly than the same investment/loan with <i>simple interest</i>.</li> <li>The <i>terms of an investment</i> include the amount of money invested, the interest rate, the length of time of the investment, and the method with which the interest is calculated, whether it be simple interest or compound interest.</li> <li>The simple interest formula is <math>I = Prt</math>, where <math>I</math> is interest, <math>P</math> is principal, <math>r</math> is the interest rate, and <math>t</math> is time (in years).</li> <li>Simple interest calculations produce a constant rate of change and a linear graph.</li> <li><i>Compound interest</i> is a percentage of the principal and the interest that is already added to the investment over time. The compound interest formula is, <math>A = P(1 + r)^t</math>, where <math>A</math> represents the final balance, <math>P</math> represents the original principal amount invested, <math>r</math> represents the annual interest rate, and <math>t</math> represents the time in years.</li> <li>Compound interest calculations produce an increasing rate of change and a graph that curves upward.</li> <li>You can determine whether the interest on an investment was calculated using simple or compound interest by analyzing an equation, table, or graph that represents the time and total investment value.</li> </ul>	8.12C 8.12D	1
2	Terms of a Loan	This lesson is about how to make financially responsible decisions based on analyzing the terms of loans. Students compare two scenarios with the same principal and time, but different interest rates, to see the effect interest has on the payback amount. Next, students make the most cost-effective decision when given two loans with the same principal, but different interest rates and lengths of time. Students also discuss appropriate questions to ask a lender regarding the terms of a loan when making decisions. The loan process is expanded to include student loans and the concept of loan deferment. By calculating the interest that is still accrued when student loan payments are deferred, students see the costly consequences of this sometimes necessary, sometimes not-so-necessary, financial decision.	<ul style="list-style-type: none"> <li>Borrowers must shop for a loan. They consider the terms of a loan and their budget to make a financially responsible decision.</li> <li>Interest rates vary depending upon the lender, the length of time of the loan, and the borrower's credit rating.</li> <li>Although one loan may be more cost-effective than another, the borrower must also consider whether the monthly payment is affordable based on their budget before selecting the most cost-effective loan.</li> <li>A <i>deferment</i> is a period of time, usually up to two years, in which a student can delay paying their student loan or the interest on their loan. Additional interest will accrue on the student loan while payments are deferred.</li> <li>Deferment of a student loan may be necessary while a college student is searching for employment, but the consequences of this decision can be costly.</li> </ul>	8.12A 8.12E 8.12F	1

3	Online Calculators	<p>Because debt is more complicated than calculating simple interest or interest compounded annually, students are introduced to the idea of using technology, such as an online-calculator with an internet-based application, to quickly perform payment options. They use this technology to determine the amount of time it takes to pay off a credit card, the interest amount, and the total debt payment amount when given the principal, interest rate, and monthly payment. Students are also made aware of a cash advances and easy access loans and the fees associated with each. Students analyze the advantages and disadvantages of each payment method.</p> <p>Similarly, students are introduced to an online calculator as another technology that can be used specifically for post-secondary student loans. They use this technology to determine the amount of monthly student loan payments, the total cost of the student loan, and the salary necessary to pay the loan when given the principal, interest rate, and time to pay off the loan. Other scenarios are also provided, in which students make use of this online tool. The lesson concludes with a series of questions that generate discussion about the necessity of planning and practicality to pay for post-secondary education.</p>	<ul style="list-style-type: none"> <li>• Debt is more complicated than calculating simple interest or interest compounded annually.</li> <li>• Technology, such as an online calculator with an internet-based application, can be used to quickly perform credit card payment options.</li> <li>• When making the minimum payment on a credit card, a small debt may take years to pay and end up costing significantly more than the original debt.</li> <li>• A <i>cash advance</i> is a service provided by credit card companies that allows their customers to take out money directly from a bank or ATM.</li> <li>• A cash advance is more costly than regular use of a credit card for merchandise/service purchases. A percentage of the cash advance is added to the original cash advance amount and a higher interest rate is applied than what is used for merchandise/service purchases.</li> <li>• An <i>easy access loan</i> is a service provided for those who do not have or do not qualify for a credit card. This is another option for a cash advance that carries a high interest rate.</li> <li>• An online calculator is available specifically to deal with post-secondary student loans. Not only can this tool be used to determine interest and monthly loan payments, it can also be used to project the salary necessary to pay the loan.</li> <li>• Both planning and practicality are necessary to make post-secondary education a viable option for all students.</li> </ul>	8.12A 8.12B 8.12E 8.12F	2
4	Financing Your Education	<p>This lesson sends a three-pronged message: (1) every student can benefit from some form of post-secondary education; (2) post-secondary tuition costs vary widely, and there is an option that makes sense and is affordable for every student, and (3) all students can find a way to manage the cost of post-secondary education. Each activity leads students through a series of fact or fiction questions to help them gain knowledge and develop the mindset that attending some form of post-secondary institution is an achievable goal.</p>	<ul style="list-style-type: none"> <li>• Post-secondary education greatly benefits everybody. 1	Volume, Lateral, and Total Surface Area of a Cylinder	Students explore how to determine the volume of a cylinder. The terms <i>cylinder</i> , <i>right cylinder</i> , <i>radius of a cylinder</i> , and <i>height of a cylinder</i> are introduced. Students identify characteristics of a cylinder such as the radius, diameter, and height. Using circular discs, students calculate the volume of a cylinder. They then answer several questions related to the formula used to compute the volume of a cylinder, including a problem that emphasizes that a specific volume may be associated with the dimensions of more than one cylinder. Students then develop the formulas for the lateral and total surface area of a cylinder and apply them in several situations.	<ul style="list-style-type: none"> <li>A <i>cylinder</i> is a three-dimensional object with two parallel, congruent circular bases.</li> <li>A <i>right cylinder</i> is a cylinder in which the bases are circles and are aligned one directly above the other.</li> <li>The formula for the volume of a cylinder is written two different ways: as <math>V = Bh</math>, where <math>V</math> is the volume of the cylinder, <math>B</math> is the area of the base of the cylinder, and <math>h</math> is the <i>height of the cylinder</i>, and as <math>V = \pi r^2 h</math>, where <math>V</math> is the volume of the cylinder, <math>r</math> is the length of the radius of the base of the cylinder, and <math>h</math> is the height of the cylinder.</li> <li>The formula for the surface area of a cylinder is <math>S = 2\pi r^2 + 2\pi rh</math>, where <math>r</math> is the length of the radius of the base and <math>h</math> is the height of the cylinder. The first term in the formula represents the area of the two circular bases, and the second term represents the area of the rectangle that covers the curved surface of the cylinder.</li> <li>The formula for the lateral surface area of a cylinder is <math>S = 2\pi rh</math>, where <math>r</math> is the length of the radius of the base and <math>h</math> is the height of the cylinder.</li> </ul>	8.6A <b>8.7A</b> <b>8.7B</b>	2
2	Volume of a Cone	Students learn how to calculate the volume of a cone and solve problems involving cones. They sketch a cone and answer questions relevant to their sketches. Students use nets for a cylinder and a cone to assemble models and explore the volume of a cone in comparison to the volume of the cylinder. Students use the formula for the volume of a cylinder and the volume of a pyramid to write the formula for the volume of a cone. They solve problems when given different dimensions of a cone, including the slant height.	<ul style="list-style-type: none"> <li>A <i>cone</i> is a three-dimensional object with a circular base and one vertex.</li> <li>The formula for the volume of the cone can be written two different ways: as <math>V = \frac{1}{3} Bh</math>, where <math>V</math> is the volume, <math>B</math> is the area of the base and <math>h</math> is the height, and as <math>V = \frac{1}{3}\pi r^2 h</math>, where <math>V</math> is the volume, <math>r</math> is the length of the radius of the base, and <math>h</math> is the height.</li> <li>The Pythagorean Theorem is used to determine the height of a cone when given the length of the radius and slant height.</li> </ul>	8.6B <b>8.7A</b> <b>8.7C</b>	2
3	Volume of a Sphere	The terms <i>sphere</i> , <i>center of a sphere</i> , <i>radius of a sphere</i> , <i>diameter of a sphere</i> , and <i>great circle</i> are introduced in this lesson. Students create a sphere out of modeling clay and place it inside a cylinder of the same height to investigate the volume occupied by the material of the sphere inside the cylinder. They arrive at a formula for the volume of a sphere. Students then use the formula to calculate the volume of various spheres. Students also use their knowledge of the circumference formula to solve problems.	<ul style="list-style-type: none"> <li>A <i>sphere</i> is defined as the set of all points in three dimensions that are equidistant from a given point called the <i>center of the sphere</i>.</li> <li>The formula for the volume of a sphere is <math>V = \frac{4}{3}\pi r^3</math>, where <math>V</math> is the volume of the sphere and <math>r</math> is the length of the radius of the sphere.</li> </ul>	<b>8.7A</b>	1
